PEDF will fill critical gaps to defend the rights of children and youth left vulnerable with the dismantling of the OCR. Specifically through PEDF, we will:

- Defend public education and challenge efforts to defund or privatize it;
- Unlock state-level civil rights enforcement pathways for families;
- Mobilize pro bono attorneys to represent students facing discrimination;
- Track and publish civil rights data, which is being eliminated rapidly, to counter harmful narratives;
- Draw on the expertise of former federal civil rights experts; and
- Convene national education leaders to guide our strategy

Co-presenter Dr. Pasha Dashtgard, an expert in the manosphere and clinical psychologist, talked about youth vulnerabilities that lead to male supremacist beliefs and misogyny. Dr. Otis McGresham, drawing on his extensive work as a prevention specialist creating healthy higher ed learning environments, elegantly made the content relatable to teachers and school staff. The webinar included three free peer education opportunities: SASH Club, Girls Learn International (our partner), and The Representation Project.

It exposes the issues and problems in K-12 education, which are eroding our democracy from within. Particular attention is paid to exposing the systemic and structural issues which impede sexual harm reduction in K-12 schools.
